### A. IMPORTANT FACTS GIVING RISE TO THE CLAIM

#### 1. Prefixx Pty Ltd (**First Respondent**):

- a. is a corporation with its registered office in New South Wales, Australia; and
- b. from at least 1 October 2021 to 24 December 2021, operated websites and a social media account located at Universal Resource Locators (**URL**):
  - i. <https://www.hqdtechaus.com>;
  - ii. <https://hqdtechaustralia.com>;
  - iii. <https://igetaustralia.com.au>; and
  - iv. [https://www.instagram.com/hqd\\_tech\\_au/](https://www.instagram.com/hqd_tech_au/)

(the **Websites**).

#### 2. Mr Brad Anthonisz (**Second Respondent**):

- a. is a natural person who resides in New South Wales, Australia;
- b. has been, since the First Respondent was registered on 13 February 2020, a director of the First Respondent;
- c. has been, since on or around 24 July 2021, the sole director and shareholder of the First Respondent; and
- d. at all relevant times, operated and/or controlled the Websites.

3. From at least 1 October 2021 to 24 December 2021, the Respondents advertised or caused to be advertised and sold nicotine vaping products (**NVP**) on the Websites. A list of the NVP advertised and sold on the Websites is set out in Annexure A (Products).
4. The Products sold on the Websites were available for purchase on a delivered basis to addresses within all States and Territories of Australia and internationally.
5. The Products are therapeutic goods within the meaning of s 3(1) of the *Therapeutic Goods Act 1989* (Cth) (**TG Act**) because they were represented to be, or were otherwise likely to be taken to be, for therapeutic uses (as defined in s 3 of the TG Act), including:
  - a. use in ceasing or partially substituting for the consumption of tobacco products, for the prevention of diseases, ailments, defects or injuries caused by use of tobacco products (such as various forms of cancer and cardiovascular disease); and
  - b. further or in the alternative, use in influencing, inhibiting or modifying physiological processes by the administration of nicotine, a substance with stimulatory and relaxant properties.

#### **Nicotine vaping products**

6. The NVP advertised on the Websites were devices containing a nicotine solution. When operated by a user, the devices were designed to apply heat to and vaporise the nicotine solution for inhalation by the user. Some of the devices allowed the nicotine solution to be refilled once it had been consumed.
7. Nicotine, as present in NVP such as the Products, was at all relevant times included in Schedule 4 of the Poisons Standard within the meaning of s 52A of the TG Act (**Poisons Standard**). Substances included in Schedule 4 of the Poisons Standard are prescription-only substances, and may only be supplied by or on the order of persons authorised to prescribe medicines under State or Territory legislation.
8. NVP are prescribed in Australia to assist persons addicted to cigarettes or other tobacco products in ceasing the use of those products, thereby preventing the various diseases, ailments, defects and injuries (such as various forms of cancer) associated with tobacco use. NVP are also, in some cases, abused for recreational purposes.

#### **Advertising goods not included in the Australian Register of Therapeutic Goods and referring to substances included in Schedule 4 to the Poisons Standard**

9. From at least 1 October 2021 to 24 December 2021, or as otherwise specified in Annexure A:
  - a. the First Respondent advertised or caused the Products to be advertised on the Websites; and

- b. the Second Respondent caused the Products to be advertised on the Websites; within the meaning of s 3(1) of the TG Act.
10. The Products were not at any relevant time entered in the Register maintained by the Applicant pursuant to s 9A(1) of the TG Act (**Register**).
11. The Products were not at any relevant time the subject of an exemption, approval or authority under the TG Act, nor an exemption, approval or authority under regulations made under the TG Act. Consequently, the Products were at all relevant times prescribed by reg 7(i) of the *Therapeutic Goods Regulations 1990* (Cth) (**TG Regulations**) for the purposes of s 42DLB(9) of the TG Act, and the advertising of the Products contravened s 42DLB(1) of the TG Act, where s 42DLB(9) of the TG Act applied.
12. The advertisements referred to at paragraph 9 above referred to the Products, being goods containing a substance, nicotine, which as contained in the Products was included in Schedule 4 to the Poisons Standard but not in Appendix H of the Poisons Standard. Those references were not authorised or required by a government or government authority (not including a foreign government or foreign government authority). The advertising of the Products therefore contravened s 42DLB(1) of the TG Act where s 42DLB(7) of the TG Act applied.
13. The Second Respondent knew each of the matters set out in paragraphs 3 to 5 and 9 to 12 above and caused or aided, abetted, counselled or procured the conduct of the First Respondent alleged in paragraph 9.

## **B. SUMMARY OF RELIEF SOUGHT FROM THE COURT**

14. The Applicant seeks the relief set out in the Originating Application, comprising:
- a. declarations under s 21 of the *Federal Court of Australia Act 1976* (Cth);
  - b. orders for pecuniary penalties under s 42Y of the TG Act; and
  - c. costs.

## **C. PRIMARY LEGAL GROUNDS FOR RELIEF SOUGHT**

15. The conduct described in paragraph 9 above was done in the course of, or in preparation for, trade or commerce between Australia and a place outside Australia, among the States, or between a State and a Territory.
16. By the conduct described in paragraph 9, the Respondents contravened s 42DLB(1) of the TG Act because s 42DLB(9) applied. A separate contravention occurred, with respect to each of the Products on each day that the Websites were published or available to be accessed by consumers.

17. By the conduct described in paragraph 9, the Respondents further contravened s 42DLB(1) of the TG Act because s 42DLB(7) applied. A separate contravention occurred, with respect to each of the Products on each day that the Websites were published or available to be accessed by consumers.
18. In the alternative to paragraphs 15 to 17, by reason of the matters alleged in paragraph 13, the Second Respondent aided, abetted, counselled or procured the First Respondent's contraventions of s 42DLB(1) alleged in paragraphs 15 to 17 above, and was therefore involved in those contraventions for the purposes of s 42YC of the TG Act.

**D. ALLEGED HARM**

19. Nicotine is highly addictive, and therefore presents a risk of abuse for recreational purposes.
20. Due to these risks, the nicotine in NVP is included in Schedule 4 to the Poisons Standard as a prescription-only substance and is not included in Appendix H to the Poisons Standard as a substance that is permitted to be advertised. As a result, the advertising of NVP is prohibited by the TG Act. This prohibition is intended to ensure that patients decide whether to use prescription-only medicines such as NVP based on information from trusted sources such as their medical practitioner, rather than from commercial advertising.
21. The risks associated with NVP vary depending on the composition of the nicotine solution. As the Products were advertised and supplied outside the TG Act framework, they were not subject to the appropriate regulatory controls required to ensure that they did not contain ingredients that presented an elevated risk to consumers and were otherwise suitable for use in smoking cessation.
22. The prohibition on the advertising of products that are not entered in the Register and not otherwise subject to an exemption, approval or authority is intended to prevent the promotion of goods posing these kinds of risks to patients or consumers, and thereby reduce consumer use of such goods.
23. Even NVP that do not contain ingredients that are specifically known to be harmful are associated with serious risks that should be managed by a patient in consultation with their medical practitioner. Those risks include poisoning, toxicity from inhalation (including seizures) and lung injury. The long-term health risks of NVP are still unclear and evidence of their potential efficacy for smoking cessation is currently mixed.
24. The Websites advertised the Products to the public at large. While viewers were asked to self-certify that they were over 18, there were no meaningful measures in place to prevent the purchase and abuse of the NVP advertised and sold through the Websites for

recreational purposes, including by children. The nature of the Products advertised on the Websites, and in particular their high concentration of nicotine, brightly coloured presentation and range of flavours are likely to encourage purchase and abuse for recreational purposes, particularly by children and young people.

25. Recreational users are likely to become addicted to nicotine. Persons addicted to nicotine have considerable difficulty ceasing the use of nicotine products if they attempt to do so and are exposed to the health risks referred to at paragraph 23 above.
26. In some cases, users of NVP subsequently begin using tobacco products such as combustible cigarettes. Where this occurs, the user will be exposed to the serious adverse health effects that can be caused by such products, including cancer, cardiovascular disease and respiratory conditions. Tobacco use is a significant public health problem in Australia, and the promotion of NVP to persons not requiring those goods for smoking cessation may therefore increase the overall public health burden created by tobacco use.
