Notice to import cannabis vaping devices

Notice to import therapeutic cannabis vaping devices and accessories not included in the Australian Register of Therapeutic Goods

About this notice

You must submit this notice to the TGA prior to the importation of a reusable vaping device that is intended for use with a medicine containing cannabis (*therapeutic cannabis vaping device*), or an unfilled cartridge, capsule, pod or other vessel (*therapeutic cannabis vaping device accessory*) that is intended for use with such a device.

You must complete a separate notice for each different type of therapeutic cannabis vaping device or therapeutic cannabis vaping device accessory that you intend to import.

You do not need to complete this notice for pre-filled cartridges, capsules, pods or other vessels containing cannabis. Different requirements apply to those goods.

If information in the form relating to your device is incomplete, we may not be able to provide you a notification number.

You should be aware that the TGA may publish certain information relating to this notice – such as the name of the sponsor and details of the device.

A *therapeutic cannabis vaping device accessory* is an empty cartridge, capsule, pod or other vessel that is intended to be filled with a medicinal cannabis product or a medicinal synthetic cannabis product and used with a cannabis vaping device.
