IMPORTANT FACTS GIVING RISE TO THE CLAIM

The Parties

- The First Respondent (**Montu**) is and was at all relevant times a licenced importer of medical cannabis products to Australia and is the parent company of a group of companies that are collectively involved in the prescribing and distribution of medical cannabis products within Australia.
- The Second Respondent (**Alternaleaf**) is and has since about 23 April 2021 been a wholly owned subsidiary of Montu and an operator of an "online medical cannabis clinic".
- 3 The Third Respondent (**Mr Strauch**) is and was at all relevant times the sole director of Alternaleaf and one of two directors of Montu.

The Websites, Social Media Accounts and light projection

- 4 From at least 21 October 2020 to the date of this Concise Statement (**Relevant Period**):
 - Montu was the registrant of the domain name "alternaleaf.com.au" which navigated to a
 website located at the Universal Resource Locator (URL) https://www.alternaleaf.com.au/
 (Alternaleaf Website); and
 - b. Mr Strauch was the registered contact for the Alternaleaf Website.
- From at least 21 October 2020 to about 22 April 2021 Montu:
 - c. used the Alternaleaf Website to operate an online platform (Alternaleaf Platform) through which:
 - i. a person could book a "telehealth" appointment with a nurse, followed by an appointment with a doctor with experience in prescribing medical cannabis, for the purpose of seeking a prescription for medical cannabis;
 - ii. the person would be charged a fee for the appointment with a doctor, but would be reimbursed the fee if the doctor did not prescribe medical cannabis for the person; and
 - iii. if the doctor prescribed medical cannabis for the person, the person could then place an order for medical cannabis products for delivery to their nominated address;
 - d. managed an "Alternaleaf" Facebook page located at the URL https://www.facebook.com/Alternaleaf, and used that page to promote the Alternaleaf Platform (Alternaleaf Facebook Account).
- 6 Since about 23 April 2021, Alternaleaf has:

- a. operated or, in the alternative, managed the Alternaleaf Website and the Alternaleaf Platform; and
- b. managed the Alternaleaf Facebook Account and, further or alternatively, used the Alternaleaf Facebook Account to promote the Alternaleaf Platform.
- 7 Since at least 21 October 2020, Mr Strauch controlled, or influenced, or was in a position to influence, the content of the Alternaleaf Website, the Alternaleaf Platform and the Alternaleaf Facebook Account.
- Since about October 2021 Alternaleaf has managed an "Alternaleaf" Instagram page located at the URL https://www.instagram.com/alternaleaf/ (Alternaleaf Instagram Account) and used that page to promote the Alternaleaf Platform.
- 9 Since about October 2021, Mr Strauch controlled, or influenced, or was in a position to influence, the content of the Instagram Account.
- Since at least October 2021, Alternaleaf has managed an "Alternaleaf" Twitter/X page located at the URL https://www.twitter.com/alternaleaf/ (Alternaleaf Twitter/X Account) and used that page to promote the Alternaleaf Platform.
- Since about October 2021, Mr Strauch controlled, or influenced, or was in a position to influence, the content of the Alternaleaf Twitter/X Account.
- 12 From 21 February 2023 to 7 March 2023:
 - a. Montu was the registrant of the domain name "medicalcannabisawarenessweek" which
 navigated to a website located at the URL
 https://www.medicalcannabisawarenessweek.com.au (MCAW Website);
 - b. Montu published the MCAW Website; and
 - c. Mr Strauch controlled, or influenced, or was in a position to influence, the content of the MCAW Website.
- On 21 February 2024, Alternaleaf caused a light projection to be displayed at the Pitt Street and Campbell Street intersection in Haymarket, Sydney (**Alternaleaf Projection**).

The Advertisements: ss 42DLB(1)(a) and 42DMA(1)(a)

- 14 During the period from at least 17 January 2022 to at least 5 April 2024:
 - a. the Alternaleaf Platform; and
 - b. the Alternaleaf Facebook Account, the Alternaleaf Instagram Account and the Alternaleaf Twitter/X Account (together, the **Social Media Accounts**),

publicly displayed a number of statements that "advertise[d]" medical cannabis products within the meaning of ss 3(1), 42DLB(1)(a) and 42DMA(1)(a) of the *Therapeutic Goods Act 1989* (Cth) (Act) (Alternaleaf Advertisements).

- The Alternaleaf Projection publicly displayed a statement that "advertise[d]" medical cannabis products within the meaning of ss 3(1) and 42DLB(1)(a) of the Act.
- 16 The Alternaleaf Advertisements, and the Alternaleaf Projection, are set out in **Annexure A**.
- 17 From 21 February 2023 to on or around 7 March 2023 the MCAW Website publicly displayed a number of statements that "advertise[d]" medical cannabis products within the meaning of ss 3(1), 42DLB(1)(a) and 42DMA(1)(a) of the Act (**MCAW Advertisements**). The MCAW Advertisements are set out in **Annexure B**.
- The medical cannabis products advertised in the Alternaleaf Advertisements, Alternaleaf Projection and MCAW Advertisements (the **advertised cannabis products**) are, and were at all relevant times, "therapeutic goods" within the meaning of 3(1) of the Act. This is because each of the advertised cannabis products were represented to be, or were likely to be taken to be, for alleviating a disease, ailment, defect or injury in persons, or influencing, inhibiting or modifying a physiological process in persons, each being a "therapeutic use" within the meaning of s 3(1) of the Act.

- By reason of the matters set out in paragraphs 2 and 4(a), 5-6, 8, 10, 12(a)-(b), 14 and 18 above, Montu "advertise[d]" and, further or alternatively, "caused the advertising" of the advertised cannabis products within the meaning of ss 42DLB(1)(a) and 42DMA(1)(a) of the Act.
- By reason of the matters set out in paragraphs 2-3, 4(b), 5-12, 14 and 17-18 above, Mr Strauch "caused the advertising" of the advertised cannabis products within the meaning of ss 42DLB(1)(a) and 42DMA(1)(a) of the Act.
- By reason of the matters set out in paragraphs 6, 8, 10, 13-15 and 18 above, Alternaleaf "advertise[d]" and, further or alternatively, "caused the advertising" of the advertised cannabis products within the meaning of ss 42DLB(1)(a) and 42DMA(1)(a) of the Act.

Prohibited Representations: s 42DLB(2)

- The Alternaleaf Advertisements and MCAW Advertisements set out in **Annexure C** contained a representation about medical cannabis regarding the treatment of mental illness, being a representation referred to in Part 1 of Schedule 2 to the *Therapeutic Goods Regulations* 1990 (Cth) (the **Regulations**), item 10, column 2.
- Pursuant to reg 6B of the Regulations, the items in column 2 of Part 1 of Schedule 2 to the Regulations specify "prohibited representations" for the purposes of s 42DJ(1) of the Act. Each representation referred to in paragraph 22 above is a "prohibited representation" within the meaning of s 42DJ(1) of the Act and, therefore, for the purposes of s 42DLB(2) of the Act (**Prohibited Representations**).
- No permission under s 42DK of the Act was, or is, in force in relation to the Prohibited Representations. Thus, s 42DLB(2) of the Act applies (for the purposes of s 42DLB(1)(b) of the Act) to the Alternaleaf Advertisements and MCAW Advertisements that contain the Prohibited Representations, and the making of those advertisements contravened s 42DLB(1) of the Act.

Restricted Representations: s 42DLB(4)

- The Alternaleaf Advertisements and MCAW Advertisements set out in **Annexure D** contained a representation which is a "restricted representation" for the purposes of s 42DLB(4) of the Act (**Restricted Representations**).
- Each is a "restricted representation" because it is a representation about medical cannabis that refers to a form of a disease, condition, ailment or defect (not including pregnancy) that is medically accepted to require diagnosis or treatment or supervision by a health practitioner who is suitably qualified, and thus is a "serious form" of that disease, condition, ailment or defect for the purposes of s 28 of the *Therapeutic Goods Advertising Code* in force under s 42BAA of the Act (**Code**).
- No approval under s 42DF of the Act or permission under s 42DK of the Act was or is in force in relation to the Restricted Representations. Thus, s 42DLB(4) of the Act applies (for the purposes of s 42DLB(1)(b) of the Act) to the Alternaleaf Advertisements and MCAW Advertisements that contain the Restricted Representations, and the making of those advertisements contravened s 42DLB(1) of the Act.

Statements suggesting medical cannabis has been recommended or approved by government agencies: s 42DLB(6)

The Alternaleaf Advertisements set out in **Annexure E** contained statements suggesting or implying that medical cannabis has been approved or recommended by or on behalf of the Therapeutic Goods Administration (**TGA**), being a government authority (**Government Endorsement Statements**). The Government Endorsement Statements are not statements about the availability of medical cannabis as a pharmaceutical benefit, were not authorised or required by a government or government authority, and were not prescribed by the Regulations. Thus, s 42DLB(6) of the Act applies (for the purposes of s 42DLB(1)(b) of the Act) to the Alternaleaf Advertisements that contain the Government Endorsement Statements, and the making of those advertisements contravened s 42DLB(1) of the Act.

Advertisements referring to substances included in the Poisons Standard: s 42DLB(7)

The Alternaleaf Projection, Alternaleaf Advertisements and MCAW Advertisements set out in **Annexures A** and **B** referred to "medical cannabis", "medicinal cannabis", "medical marijuana",

"cannabidiol", "cannabis", "CBD oil", "plant-based medicine" and "plant medicine", which phrases refer to (inter alia) medical cannabis products that:

- a. can be lawfully prescribed by a doctor to a patient in Australia, and thus supplied in Australia for use in humans in accordance with the Act (specifically, under s 19 of the Act), and therefore are substances included in either:
 - i. the limb (d) definition of "cannabis" in Schedule 8 of the *Therapeutic Goods (Poisons Standard February 2024) Instrument 2024* (**Poisons Standard**) or the Poisons Standard that was current for the entire period in which the Alternaleaf Projection, Alternaleaf Advertisements and MCAW Advertisements were made; or
 - ii. the definition of "cannabidiol" in Schedule 4 of the Poisons Standard or the Poisons Standard that was current for the entire period in which the Alternaleaf Projection, Alternaleaf Advertisements and MCAW Advertisements were made.

These products are not excluded by the Schedule 8 definition of "cannabis" by reason of any of limbs (e) to (h) of that definition or the Schedule 4 definition of "cannabidiol" by reason of any of the limbs (c) to (d) of that definition; and

- b. were not, and are not, included in Appendix H of the Poisons Standard, or Appendix H of the Poisons Standard that was current for any part of the period in which the Alternaleaf Projection, Alternaleaf Advertisements and MCAW Advertisements were made.
- The references were not and are not authorised or required by a government or government authority. Thus, s 42DLB(7) of the Act applies (for the purposes of s 42DLB(1)(b) of the Act) to the Alternaleaf Projection, Alternaleaf Advertisements and MCAW Advertisements, and the making of those advertisements contravened s 42DLB(1) of the Act.

Advertisements that did not comply with ss 9(1)(a), 9(1)(c) and (3)(f) of the Code

- The Alternaleaf Advertisements and MCAW Advertisements set out in **Annexure F** are about medical cannabis and contained a statement that, expressly or by implication:
 - a. represents medical cannabis to be safe, or without harm or side-effects;
 - b. represents medical cannabis to be infallible, unfailing, magical or miraculous; or
 - c. compares medical cannabis with other therapeutic goods, classes of therapeutic goods, or therapeutic services and such comparison suggests that the comparator goods or services are harmful or ineffectual.

(together, the Safe and Proper Use Statements).

The Alternaleaf Advertisements and MCAW Advertisements that contain the Safe and Proper Use Statements did not comply with ss 9(1)(a), (b) and/or (c) and/or s 9(3)(f) of the Code, so that the making of those advertisements contravened s 42DMA(1) of the Act.

Advertisements that did not comply with s 11(3) of the Code

- The Alternaleaf Advertisements set out in **Annexure G** are about medical cannabis and referred, expressly or by implication, to scientific or clinical research but did not identify the researcher, and/or the financial sponsor of the research (where that ought to have been known by Alternaleaf, Montu or Mr Strauch, relevantly) and/or the research by proper citation to enable consumers to access that research (**Scientific / Clinical Representations**).
- The Alternaleaf Advertisements that contain the Scientific / Clinical Representations did not comply with s 11(3) of the Code, so that the making of those advertisements contravened s 42DMA(1) of the Act.

Advertisements that did not comply with s 24(4)(c) and 6(d) of the Code

The Alternaleaf Advertisements and MCAW Advertisements set out in **Annexure H** contain a testimonial or endorsement about medical cannabis given by a current or former "health practitioner" within the meaning of s 3(1) of the Act or a "health professional" within the meaning of s 4 of the Code (**Health Worker Testimonials & Endorsements**).

The Alternaleaf Advertisements and MCAW Advertisements that contain the Health Worker Testimonials & Endorsements did not comply with s 24(4)(c) and 24(6)(d) of the Code, so that the making of those advertisements contravened s 42DMA(1)(b) of the Act.

Communications between the TGA and Mr Strauch

37 Between 5 August 2020 and 14 June 2023 the TGA communicated with Mr Strauch in his capacity as a director and representative of Montu, in writing and orally, and informed Mr Strauch that the Alternaleaf Platform, Social Media Accounts and MCAW Website were or might be advertising medical cannabis as therapeutic goods in contravention of the Act. Mr Strauch responded to the TGA's communications on behalf of Montu and Alternaleaf.

RELIEF SOUGHT FROM THE COURT

The Secretary seeks the relief set out in the accompanying originating application (which includes an application for interlocutory relief) dated 16 April 2024.

PRIMARY GROUNDS FOR THE RELIEF SOUGHT

- By reason of the matters set out in paragraphs 19 and 22-36 above, on each day that each Alternaleaf Advertisement and MCAW Advertisement was publicly displayed, Montu contravened ss 42DLB(1) and 42DMA(1) of the Act.
- 40 Further or alternatively to paragraph 39 above, by reason of the matters set out in 21 and 22-36 above, on each day that each Alternaleaf Advertisement was publicly displayed, Alternaleaf contravened ss 42DLB(1) and 42DMA(1) of the Act.
- 41 On the day of the Alternaleaf Projection, Alternaleaf contravened ss 42DLB(1) of the Act.
- Further or alternatively to paragraph 39 above, by reason of the matters set out in paragraphs 2-3, 4(a)-(b) and 5-11 above, Montu aided, abetted, counselled or procured Alternaleaf's contraventions of ss 42DLB(1) and 42DMA(1) of the Act referred to in paragraph 40 above and, by reason of that conduct, contravened s 42YC(1) of the Act.
- Further or alternatively to paragraphs 39 and 40 above, by reason of the matters set out in paragraphs 3, 4(b), 7, 9, 11 and 12(c) above, on each day that each Alternaleaf Advertisement and MCAW Advertisement was publicly displayed, Mr Strauch contravened ss 42DLB(1) and 42DMA(1) of the Act.
- Alternatively to paragraph 43 above, by reason of the matters set out in paragraphs 3, 4(b), 7, and 9, 11 and 12(c) above, Mr Strauch, aided, abetted, counselled or procured Montu's and Alternaleaf's contraventions of ss 42DLB(1) and 42DMA(1) of the Act referred to in paragraphs 39 and 40 above and, by reason of that conduct, contravened s 42YC(1) of the Act.
- By reason of Mr Strauch's position and activities as a director of Alternaleaf and Montu and the matters set out in paragraphs 3, 4(b), 7, 9, 11, 12(c) and 37 above, Mr Strauch was an executive officer of both Montu and Alternaleaf who knew that Montu's and Alternaleaf's ss 42DLB(1) and 42DMA(1) contraventions would occur, was in a position to influence the conduct of Montu and Alternaleaf in relation to the contraventions and failed to take all reasonable steps to prevent the contravention (which steps included directing Montu and Alternaleaf to cease advertising medical cannabis products in the way that contravened ss 42DLB(1) and 42 DMA(1)). By reason of the matters set out in this paragraph, Mr Strauch contravened s 54B(3) of the Act.

ALLEGED HARM SUFFERED

- The promotion to consumers of medical cannabis products that are substances included in Schedule 4 and Schedule 8 of the Poisons Standard, but not included in Annexure H to the Poisons Standard, poses a risk to public health and safety in circumstances where:
 - a. the safety, quality and efficacy of such medical cannabis products as a treatment for serious medical conditions has not yet been the subject of extensive research or clinical trials and, therefore, users may suffer adverse medical outcomes from their use;
 - b. there is a risk that consumers who use such medical cannabis products may cease, delay or avoid conventional treatments and thereby suffer adverse medical outcomes;

- c. such medical cannabis products can have acute and long-term adverse side effects, including an adverse effect on the metabolism and on the actions of other medicines, which can result in adverse medical outcomes;
- d. use of such medical cannabis products may cause cannabis dependence, which may increase a consumer's quantity or frequency of purchase and use of cannabis, and thereby cause financial loss or the adverse outcomes referred to in sub-paragraphs (a) and (c) above;
- e. the growth in the use of single-issue and/or single-medicine online prescribing models of care can result in fragmented healthcare which, in turn, may cause patients to suffer adverse medical outcomes due to inadequate transfers of information between treating practitioners and unclear treatment responsibilities;
- f. the promotion may cause consumers to self-select such medical cannabis as a medical treatment and such self-selection may expose them to adverse outcomes, such as those referred to in sub-paragraphs (a)-(d) above, which outcomes might be avoided by a different treatment strategy selected in consultation with a prescribing doctor who is not employed by or affiliated with entities involved in the prescription and distribution of medical cannabis;
- g. it may cause a consumer who uses cannabis as a recreational drug to readily obtain such medical cannabis products via the Alternaleaf Platform, which may increase a consumer's quantity or frequency of purchase and use of the products and, therefore, cause the adverse outcomes referred to in sub-paragraph (c) above.
- 47 The public is generally exposed to the risk of harm by the publication of information that:
 - a. encourages a person to use or seek out medicinal cannabis products in preference to other medicines that have been prescribed by the person's medical or health practitioner, or would be prescribed by them, by making representations to the effect that such medicines are safe or have been approved or endorsed by a medical practitioner or government authority; or
 - b. uses references to scientific research to bolster the apparent credibility of therapeutic goods, without giving consumers sufficient information to allow them to evaluate the credibility of that research.
- If the contravening advertising continues it may cause other entities and individuals who conduct business in the market of prescribing or enabling the prescription of medical cannabis to advertise medical cannabis in contravention of the Act, leading to the adverse outcomes referred to in paragraphs 46-47 above.
