IMPORTANT FACTS GIVING RISE TO THE CLAIM

The Parties

- 1. The Applicant is the Secretary of the Department of Health, Disability and Ageing, and administers the *Therapeutic Goods Act 1989* (Cth) (**Therapeutic Goods Act**).
- 2. The First Respondent, AG Therapeutics Pty Ltd, trading as **Atlus**, is a company incorporated in Australia. It operates an online medicinal cannabis clinic in Australia.
- 3. The Second Respondent, **Mamamia**.com.au Pty Ltd, is a company incorporated in Australia. It operates a news and lifestyle website by the same name.
- 4. The Third Respondent, **News Life** Media Pty Ltd, is a company incorporated in Australia. It operates a lifestyle website called Body + Soul.
- 5. The Fourth Respondent, Straight Up PR Pty Ltd, is a company incorporated in Australia. It provides marketing services. On 30 June 2022, Atlus engaged Straight Up pursuant to a 'Public Relations Campaign Agreement' (PR agreement) to secure media exposure for Atlus and to compile public relations materials for that purpose.
- 6. The Fifth Respondent, Dr Shimal Jobanputra, is the sole director and secretary of Atlus.

Body + Soul article

7. Between 12 August 2022 and 19 September 2023, an article appeared on the Body + Soul website entitled "5 health conditions you didn't know medical cannabis could help with" (Body + Soul article). The article asserted that medicinal cannabis could improve a

are set out in Annexure A. 8. The author of the article, (who wrote under the name '), was at all relevant times registered as a medical practitioner. The article described her as a doctor that worked at Atlus and included a link to the Atlus website. Mamamia article Between 9 September 2022 and 9 February 2023, an article appeared on the Mamamia 9. website entitled "takes CBD oil daily for her anxiety. Here's what she wants people to know" (Mamamia article). The article contained descriptions by its author and from an interviewee, grant and an interviewee, grant and successfully treated her anxiety using cannabidiol. The representations made by the article are set out in Annexure B. 10. As well as a website, Mamamia operated a Facebook page. A link to the Mamamia article, which contained the article's title, also appeared on Mamamia's Facebook page on and from 10 September 2022 (Mamamia Facebook post). The representations made in the Mamamia Facebook post are set out in Annexure B. 11. The author of the article, (who wrote under the name '), was at all relevant times registered as either or both an Enrolled Nurse and a Registered Nurse. At all relevant times, mother, , was an employee of Atlus Medical Pty Ltd, a company which provided labour hire services to

Role of Straight Up and Dr Jobanputra

Atlus.

12. Straight Up coordinated the publication of the Body + Soul article, the Mamamia article and the Mamamia Facebook post pursuant to its engagement by Atlus under the PR agreement. Among other steps, it approached News Life and Mamamia to suggest the placement of the respective articles on their websites, assisted Atlus staff to prepare or contribute to the preparation of the articles, reviewed the articles and submitted them for publication.

Atlus, and her duties involved, amongst other things, carrying out marketing activities for

13. Dr Jobanputra facilitated the preparation of the Body + Soul article and the Mamamia article, had input into the preparation of the articles, was aware of their content, and corresponded with Straight Up to approve the articles before they were placed for publication.

Atlus advertising

- 14. Atlus operated a website at https://atlus.com.au (**Atlus website**), as well as Facebook pages and an Instagram page (**Atlus social media accounts**).
- 15. From 14 November 2022 to 18 August 2023, the Atlus website and Atlus social media accounts advertised medicinal cannabis as set out in Annexure C (Atlus advertising). The Atlus advertising promoted the use or supply of medicinal cannabis products and many of the specific advertisements represented that medicinal cannabis products were suitable to treat a range of health and medical conditions.
- 16. On 9 February 2023, the Applicant wrote to Atlus raising his concerns that the Mamamia article and the Atlus website may have breached the Therapeutic Goods Act and the *Therapeutic Goods (Therapeutic Goods Advertising Code) Instrument 2021.* On 14 July 2023, the Applicant wrote to Atlus raising his concerns that the Atlus website and social media may have continued to breach the Therapeutic Goods Act. Certain of the advertisements in Annexure C were published after some or all of this correspondence was received by Atlus. On 21 August 2023, the Applicant wrote to Atlus raising his concerns that the Body + Soul article, the Atlus website and social media accounts may have breached and continued to breach the Therapeutic Goods Act and the Code.

RELIEF SOUGHT FROM THE COURT

17. The Applicant seeks the relief set out in the accompanying Originating Application, comprising declarations under s 21 of the *Federal Court of Australia Act 1976* (Cth), orders for pecuniary penalties under s 42Y of the Therapeutic Goods Act and costs.

PRIMARY GROUNDS FOR RELIEF SOUGHT

- 18. The Applicant is entitled to apply for a civil penalty by reason of s 42Y(1) of the Therapeutic Goods Act.
- 19. Each of the Mamamia article, the Mamamia Facebook post, the Body + Soul article and the Atlus advertising set out in Annexures A, B and C advertised medicinal cannabis within the meaning of s 3(1) of the Therapeutic Goods Act. Medicinal cannabis is a therapeutic good within the meaning of s 3(1) because it was, in each advertisement, represented to be for therapeutic use (as that term is also defined in s 3(1)) including for preventing, curing or alleviating a disease, ailment, defect or injury in persons.
- 20. The Mamamia article, the Mamamia Facebook post, the Body + Soul article and the Atlus advertising set out in Annexures A, B and C referred to "medicinal cannabis", "medical cannabis", "medical marijuana", "plant medicine", "cannabinoids", "CBD", "THC", "CBD oil", "cannabidiol", "plant-based therapies", or "natural therapies" that "target the

endocannabinoid system". Those terms and phrases, both alone and considered in the context of each advertisement, referred to medicinal cannabis products that:

- (a) could only be lawfully prescribed by a doctor to a patient in Australia, and thus supplied in Australia for therapeutic use, in accordance with the Therapeutic Goods Act (specifically, under s 19 of the Therapeutic Goods Act), and were therefore goods containing substances included in either:
 - (i) the limb (d) definition of "cannabis" in Schedule 8 to the applicable Poisons
 Standard made pursuant to s 52D(2)(b) of the Therapeutic Goods Act in force
 during the relevant period (**Poisons Standard**); or
 - (ii) the definition of "cannabidiol" in Schedule 4 to the Poisons Standard:
- (b) were not excluded from:
 - (i) in the case of the products referred to in paragraph 20(a)(i) above—the Schedule 8 definition of "cannabis" by reason of any of limbs (e) to (h) of that definition:
 - (ii) in the case of the products referred to in paragraph 20(a)(ii) above—the Schedule 4 definition of "cannabidiol" by reason of any of the limbs (c) to (d) of that definition;
- (c) were not included in Appendix H of the Poisons Standard; and
- (d) reference to which was not authorised or required by a government or government authority.
- 21. The doctors engaged by Atlus in fact prescribed products meeting the description in paragraph 20 above to Atlus' customers.

Body + Soul article

- 22. News Life displayed the Body + Soul article online and thereby advertised, or caused to be advertised, medicinal cannabis.
- 23. The representations set out in Annexure A shaded in green are "prohibited representations" for the purposes of s 42DLB(2)(a) of the Therapeutic Goods Act. No permissions were in force in relation to them under s 42DK, contrary to s 42DLB(2)(a). In displaying those representations online, News Life therefore contravened s 42DLB(1) because s 42DLB(2)(a) applied.
- 24. The representations set out in Annexure A shaded in orange are "restricted representations" for the purposes of s 42DLB(4)(a) of the Therapeutic Goods Act. No approval was in force in relation to them under s 42DF, nor was a permission in force in

- relation to them under s 42DK. In displaying those representations online, News Life therefore contravened s 42DLB(1) because s 42DLB(4)(a) applied.
- 25. News Life also contravened s 42DLB(1) of the Therapeutic Goods Act because, for the reasons set out at paragraphs 20 and 21 above, s 42DLB(7) applied.
- 26. The Body + Soul article contained express and implied endorsements of medicinal cannabis products for the treatment of a variety of health conditions, being those conditions identified in columns B and C of Annexure A. Those endorsements were contrary to s 24(6)(d) and (e) of the Code because was, at that time, a person who was a current health practitioner and who represented herself, including for the reasons set out at paragraph 8 above, as being qualified or trained to diagnose, treat or prevent disease, ailment, defect or injury in persons. News Life therefore contravened s 42DMA(1) of the Therapeutic Goods Act.
- 27. Each of the following persons also caused the advertising of medicinal cannabis by way of the Body + Soul article:
 - (a) Atlus engaged and directed Straight Up, pursuant to the PR agreement, to facilitate the preparation and publication of the Body + Soul article and, through Dr Jobanputra, approved the article for publication; and
 - (b) Straight Up, pursuant to the PR agreement, facilitated the preparation and publication of the Body + Soul article.
- 28. Accordingly, for the same reasons set out in paragraphs 22 to 25 above, Atlus and Straight Up also contravened s 42DLB(1) of the Therapeutic Goods Act (because ss 42DLB(2)(a), (4)(a) and (7) applied). For the same reasons as set out in paragraph 26 above, Atlus and Straight Up contravened s 42DMA(1).
- 29. At all relevant times, Dr Jobanputra was aware of the contents of the Body + Soul article, its publication, and that no permissions or approvals were in force in relation to it under ss 42DF or 42DK of the Therapeutic Goods Act. For these reasons and those set out at paragraph 13 above, pursuant to s 42YC(1), Dr Jobanputra was involved in News Life's contraventions as set out in paragraph 22 to 26 above.

Mamamia article

- 30. Mamamia displayed the Mamamia article online, and posted the Mamamia Facebook post on its account linking to the article, and thereby advertised, or caused to be advertised, cannabidiol.
- 31. The representation that cannabidiol can treat anxiety (set out in row 1 of Annexure B) is a "prohibited representation" for the purposes of s 42DLB(2)(a) of the Therapeutic Goods

- Act. No permission was in force in relation to it under s 42DK. Mamamia therefore contravened s 42DLB(1) because s 42DLB(2)(a) applied.
- 32. Mamamia also contravened s 42DLB(1) of the Therapeutic Goods Act because, for the reasons set out above at paragraphs 20 to 21 above, s 42DLB(7) applied.
- 33. The Mamamia article contained testimonials concerning the successful use of cannabidiol for anxiety.
 was at all relevant times a current or former health practitioner or health professional for the purposes of ss 24(4)(c) and 24(6)(d) of the Code.
 was at all relevant times the immediate family member of a 'relevant person' under s 24(4)(a) of the Code because her mother was a person involved in the marketing or supply of cannabidiol. The Mamamia article did not disclose that relationship, contrary to s 24(4)(b) of the Code. The Mamamia article therefore did not comply with s 24 of the Code, contrary to s 24(1) of the Code. Mamamia therefore contravened s 42DMA(1) of the Therapeutic Goods Act.
- 34. Each of the following persons also caused the advertising of cannabidiol by way of the Mamamia article:
 - (a) Atlus engaged and directed Straight Up, pursuant to the PR agreement, to facilitate the preparation and publication of the Mamamia article and, through Dr Jobanputra, approved the article for publication;
 - (b) Straight Up, pursuant to the PR agreement, facilitated the preparation and publication of the Mamamia article.
- 35. For the same reasons set out in paragraphs 30 to 32 above, Atlus and Straight Up thereby contravened s 42DLB(1) of the Therapeutic Goods Act (because s 42DLB(2)(a) and (7) applied). For the same reasons as set out in paragraph 33 above, Atlus and Straight Up contravened s 42DMA(1).
- 36. At all relevant times, Dr Jobanputra was aware of the contents of the Mamamia article, its publication, and that no permission was in force in relation to it under s 42DK of the Therapeutic Goods Act. For these reasons and those set out at paragraph 13 above, pursuant to s 42YC(1), Dr Jobanputra was involved in Mamamia's contraventions set out at paragraphs 30 to 33 above.

Atlus advertising

- 37. Atlus displayed the Atlus advertising on the Atlus website or the Atlus social media accounts and thereby advertised, or caused to be advertised, medicinal cannabis.
- 38. The representations set out in Annexure C that are shaded in green are "prohibited representations" for the purposes of s 42DLB(2)(a) of the Therapeutic Goods Act. No

- permissions were in force in relation to them under s 42DK. Atlus therefore contravened s 42DLB(1) because s 42DLB(2)(a) applied.
- 39. The representations set out in Annexure C that are shaded in orange are "restricted representations" for the purposes of s 42DLB(4)(a) of the Therapeutic Goods Act. No approval was in force in relation to them under s 42DF, nor was a permission in force in relation to them under s 42DK. Atlus therefore contravened s 42DLB(1) because s 42DLB(4)(a) applied.
- 40. Atlus also contravened s 42DLB(1) of the Therapeutic Goods Act because, for the reasons set out at paragraphs 20 to 21 above, s 42DLB(7) applied.

ALLEGED HARM SUFFERED

- 41. The advertising of medicinal cannabis products poses a significant risk to the health and safety of the public when those products are advertised as a treatment for a range of serious illnesses in circumstances where the quality, safety and efficacy of those products have not undergone pre-market evaluation against the purposes for which they are to be used. There is a risk that persons using them may cease, delay or avoid conventional treatments and thereby suffer adverse clinical outcomes. Medicinal cannabis products can also cause adverse effects on the metabolism and action of other medicines, and dependence.
- 42. The Therapeutic Goods Act restricts the advertising of prescription-only medicines, and the making of restricted and prohibited representations in advertisements for therapeutic goods, because only health professionals, and not the general public, have sufficient training, experience and knowledge to properly evaluate the content of such advertising. Prescription-only medicines have a higher risk profile than less restricted medicines, and the restriction on their advertising corresponds to the restriction on their supply.
- 43. The advertising of prescription-only medicines to the public can lead to inappropriate demand for such medicines, including pressure from patients on medical practitioners to prescribe such medicines where their use is not clinically indicated.
- 44. The conduct alleged in this Concise Statement undermines the integrity of the therapeutic goods regulatory framework which seeks to protect the community from misinformation and ensures that access to healthcare is safe and based on clinically informed decision making by individual patients.
- 45. To the extent that customers have purchased and used medicinal cannabis products for therapeutic purposes and not experienced any health benefit, they are likely to have suffered financial loss connected to the purchase of the products.

- "I can't deny the impact that I have seen in my own life since I started using it in 2020".
- "I know how much CBD helped me through one of the most anxious times of my life, so I was excited to chat to someone else who both lives with anxiety, and found relief with CBD too".
- "see suffering from anxiety since her early teens..."
