ANTISERUM REAGENT – A/Singapore/GP20238/2024-like

**For Single Radial Immunodiffusion Assay of
Influenza Virus Haemagglutinin**

1. Introduction

Influenza antiserum reagent TGA Lot AS466 is prepared for single radial immunodiffusion (SRID) assay of A/Singapore/GP20238/2024-like antigens.

2. Unitage

No unitage is assigned to this material.

3. Contents

Country of origin of biological material: Australia

Animal species: Domestic sheep (*Ovis aries*)

Donor sheep breed: Australian Merino Cross

The sheep originated, were continuously reared, and were slaughtered in Australia.

The haemagglutinin (HA) used to immunise the sheep was derived from a formalin inactivated pool of A/Singapore/GP20238/2024 (IVR-277). The HA was purified with a protease treatment step prior to immunisation. All sheep used in the production of antisera were inspected by a veterinary surgeon prior to terminal bleed to confirm their disease-free status. The antiserum was diluted 1:1 with phosphate-buffered saline (PBS) and contains 0.05% sodium azide as a preservative.

4. Caution

THIS PREPARATION IS NOT FOR ADMINISTRATION TO HUMANS.

The preparation does not contain material of human origin.

As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures probably will include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

5. Use of material

This antiserum is suitable for SRID testing of A/Singapore/GP20238/2024-like antigens. For antigens containing approximately 30 µg HA per mL, add 2 µL of the undiluted antiserum to 1 mL of agarose. It may be necessary to change the antiserum concentration according to local laboratory conditions.

Antiserum reagent AS466 should be used according to the method described by Wood, JM, Schild, GC, Newman, RW, and Seagroatt, VA, Journal of Biological Standardization, 1977, 5, 237–247.

6. Stability

It is the policy of WHO not to assign an expiry date to their international reference materials. TGA follows the policy of WHO with respect to its reference materials and they remain valid with the assigned potency and status until withdrawn or amended. Reference materials should be stored on receipt below -20°C as indicated on the label.
