# ANTISERUM REAGENT - A/Missouri/11/2025-like

# For Single Radial Immunodiffusion Assay of Influenza Virus Haemagglutinin

Lot: AS467 (DOM: NOV 2025)

#### 1. Introduction

Influenza antiserum reagent TGA Lot AS467 is prepared for single radial immunodiffusion (SRID) assay of A/Missouri/11/2025 (H1N1)pdm09-like antigens.

# 2. Unitage

No unitage is assigned to this material.

### 3. Contents

**Country of origin of biological material:** Australia

**Animal species:** Domestic sheep (Ovis aries)

**Donor sheep breed:** Australian Merino Cross

The sheep originated, were continuously reared, and were slaughtered in Australia.

The purified haemagglutinin (HA) used to immunise the sheep was derived from a formalin inactivated pool of A/Missouri/11/2025 (IVR-279). The HA was purified with a protease treatment step prior to immunisation. All sheep used in the production of antisera were inspected by a veterinary surgeon prior to terminal bleed to confirm their disease-free status. The antiserum was diluted 1:1 with phosphate-buffered saline (PBS) and contains 0.05% sodium azide as a preservative.

# 4. Caution

The preparation does not contain material of human origin.

As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. #### 5. Use of material

This antiserum is suitable for SRID testing of A/Missouri/11/2025-like antigens. For antigens containing approximately 30  $\mu g$  HA per mL, add 1.9  $\mu L$  of the undiluted antiserum to 1 mL of agarose. It may be necessary to change the antiserum concentration according to local laboratory conditions.
