**Influenza Virus Haemagglutinin – A/Darwin/1415/2025 (CVR-400)**

**Lot: 2026/160B (DOM: Mar 2026)**

**1. Introduction**

Influenza antigen reagent TGA Lot 2026/160B is prepared for use in a single radial immunodiffusion assay (SRID) of A/Darwin/1415/2025 (CVR-400) cell-derived antigens using an appropriate antiserum reagent.

**2. Unitage**

Assigned potency of Lot 2026/160B:

**TBC µg (microgram) of HA per mL**, after reconstitution of the lyophilized reagent in 1 mL of distilled water.

Lot 2026/160B was calibrated using sheep antiserum Lot AS469 raised against egg-derived A/Darwin/1454/2025-like haemagglutinin.

**3. Contents**

**Country of origin of biological material:** United States

Lot 2026/160B was produced in cultured Madin-Darby canine kidney (MDCK) cells. The material was inactivated with beta-propiolactone (βPL), and prior to lyophilisation, was diluted with an equal volume of 1% w/v sucrose (in 0.8% w/v sodium chloride). It was thoroughly mixed and dispensed for freeze-drying in 1.0 mL volumes as described by Campbell, PJ, Journal of Biological Standardization, 1974, 2, 249–267.

The mean weight of tested vials was 0.997 g with a coefficient of variation of 0.55%.

**4. Caution**

**THIS PREPARATION IS NOT FOR ADMINISTRATION TO HUMANS.**

The preparation does not contain material of human origin.

As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures probably will include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

## 5. Use of material

For all practical purposes each vial contains the same quantity of the substance listed above. Reconstitute the total contents of one vial of reagent with 1 mL of distilled water. Allow to stand for a minimum of 5 minutes before use to allow for complete solubilisation of freeze-dried material. Lot 2026/160B should be used according to the method described by Wood, JM, Schild, GC, Newman, RW, and Seagroatt, VA, Journal of Biological Standardization, 1977, 5, 237–247, with the following modification.

It is recommended that Lot 2026/160B and test virus antigens be treated with Zwittergent 3-14 detergent (Calbiochem-Behring, La Jolla, CA, USA) before the SRID assay. Suitable incubation conditions are as follows: add 50 microlitres of 10% (w/v) Zwittergent 3-14 to 450 microlitres of antigen and incubate for 30 minutes at room temperature (20–25°C). Dilutions of Zwittergent 3-14 treated antigens are then added to wells in the SRID plates and incubated at 20–25°C.

Lot 2026/160B should be used to assay antigens using a suitable antiserum reagent.

No attempt should be made to weigh out any portion of the freeze-dried material. Unopened vials should be stored at below –20°C but storage of reconstituted reagent is not recommended. To remove the reconstituted material from the vial, it is necessary to use some form of transfer pipette rather than a volumetric pipette. The contents of the vials should not be assumed to be sterile.

## 6. Stability

It is the policy of WHO not to assign an expiry date to their international reference materials which remain valid with the assigned potency and status until withdrawn or amended. TGA follows the policy of WHO with respect to its reference materials. Reference materials should be stored as indicated on the label. In addition, once reconstituted, diluted or aliquoted, users should determine the stability of the material according to their own method of preparation, storage and use.

## 7. Citation

In all publications (or data sheets for immunoassay kits) in which this preparation is used as an assay calibrant, it is important that the title of the preparation, vial code and the name and address of TGA are cited correctly.
