s47E - I do want you to consider de-identifying all letters (include the one to Veganics – also involving names in screenshots being redacted). I understand this is allowable under our policy. Given the nature of the many statements made by the sponsor in question on public forums, de-identifying decision makers/signatories seems a prudent step.

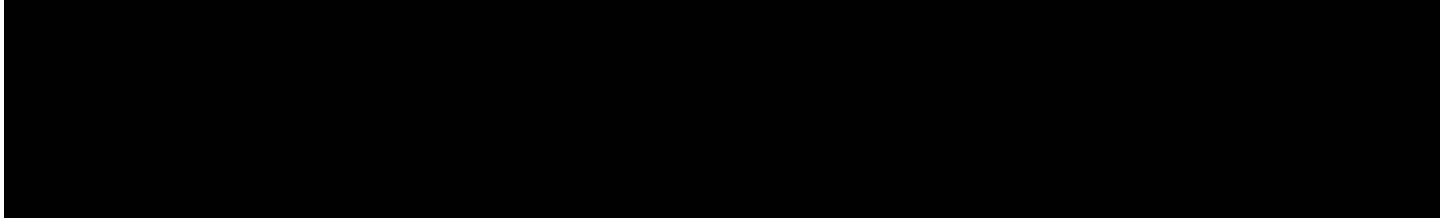
