- Ads for all medicines must include the statement: FOLLOW THE DIRECTIONS FOR USE
- Refer to Code sections 13(2)(c) and 13(6)

## Consistency with ARTG entry

- This version includes the claim :
  - 'brings your blood sugar into the healthy range'
- This indication is not consistent with the ARTG entry for the goods, which specifies that the product presentation must not refer to raising or lowering blood sugar levels
- It is also not accurate or truthful, so is therefore false and misleading
- Refer to Code sections 9(a), 9(b) and 9(d)
