TGA Internet site proposed website structure

What is website structure?

Website structure, also referred to as information architecture, is the foundation for web design. It is the blueprint of the site upon which all other aspects are built, i.e. the way information is grouped and the terminology used.

An effective website structure enables people to step logically through a website confident they are getting closer to the information they require.

The content will be organised into the categories, topics & sub-topics.

Every piece of content must fit into at least one topic under at least one category. (Content may be referenced (linked) from more than one place within the website, but all content must have one main 'parent' topic page.)

Please note: this does not preclude new categories, topics and/or sub-topics being added at a later date if necessary.

Categories

The categories will be displayed as global navigation on every web page (placement will depend on final web design). It is important that category names be as short as possible, but still meaningful, so that when a visitor sees them on a web page, they can easily guess what information will be found if they click on that link.

Category	Comments/explanation/type of information
SAFETY INFORMATION	This section will contain safety advice, such as alerts & recalls and information about how the safety of therapeutic goods is monitored.
FOR CONSUMERS	This section will contain plain English content targeted to consumers, and will include links into the Safety category, as well as bridging (general) information with links into the Regulation category for people who want more detail.
FOR HEALTH PROFESSIONALS	This section will contain content targeted to health professionals and will include links into the Safety category, as well as bridging (general) information with links into the Regulation category for people who want more detail.
FOR INDUSTRY	This section will contain content targeted to sponsors & manufacturers and will include links into the Regulatory information category.
REGULATORY INFORMATION	This section will contain information about how therapeutic goods are regulated by the TGA.
ABOUT THE TGA	This section will contain corporate and historical information about the TGA and information about what the TGA does/doesn't do.
NEWS ROOM	Information about what the TGA is doing, i.e. the place you go to get the' news'.






