- 1. The First Respondent is a corporation, capable of being sued in its own name.
- 2. The Second Respondent is the sole director of the First Respondent.

The Website Advertisements

- Between at least January 2019 and 2 March 2020, the First Respondent maintained, or caused to be maintained, a website located at Universal Resource Locator (URL) www.evolutionsupplements.com.au (Website).
- 4. Within the period referred to in paragraph 3 above, the Website displayed advertisements in relation to each of the goods listed in Schedule 2 to this Statement of Claim (**Website**Advertisements).

Particulars

- (a) The Website Advertisements were displayed at the URLs listed in Schedule 2, during the periods listed in Schedule 2.
- (b) The Website Advertisements were available 24 hours per day, for the periods they were displayed.

5. By maintaining the Website, or causing the Website to be maintained, the First Respondent advertised, or caused to be advertised, each of the goods listed in Schedule 2 to this Statement of Claim (**Website Goods**).

Advertising goods that are not entered in the Register

6. Each of the Website Goods is and was, within the period referred to in paragraph 3 above, a therapeutic good within the meaning of s 3(1) of the *Therapeutic Goods Act 1989* (Cth) (**TG Act**).

Particulars

- (a) Each of the Website Goods is or was, at all relevant times, represented to be, or is or was, at all relevant times, likely to be taken to be, for a therapeutic use, having regard to the representations made concerning the effects and uses of the Website Goods in the Website Advertisements.
- (b) Each of the Website Goods is or was, at all relevant times, represented to be, or is or was, at all relevant times, likely to be taken to be, for use in influencing, inhibiting or modifying a physiological process in persons, having regard to the representations made in column 2 of Schedule 3 to this Statement of Claim in the Website Advertisements in respect of those Website Goods listed in column 1 of Schedule 3.
- (c) None of the Website Goods is or was, at any relevant time, the subject of an order in force under section 7 of the TG Act.
- (d) None of the Website Goods is or was, at any relevant time, a good for which there is a standard within the meaning of s 4(1) of the *Food Standards Australia New Zealand Act 1991* (Cth).
- (e) None of the Website Goods is or was, at any relevant time, a good which, in Australia or New Zealand, has a tradition of use as food for humans in the form in which it is presented.
- (f) None of the Website Goods is or was, at any relevant time, covered by a determination under s 7AA of the TG Act.
- 7. None of the Website Goods is or was, at any relevant time, entered in the Australian Register of Therapeutic Goods (**Register**).

- 8. None of the Website Goods is or was, at any relevant time, the subject of an exemption, approval or authority under the TG Act, nor an exemption, approval or authority under regulations under the TG Act.
- 9. The advertisements for the Website Goods refer or referred to the rapeutic goods not entered in the Register that are and were at all relevant times prescribed by reg 7(i) of the *Therapeutic Goods Regulations 1990* (Cth), for the purposes of s 42DLB(9) of the TG Act.
- 10. The references to the advertisements for the Website Goods were not at any relevant time authorised or required by a government or government authority.
- 11. The advertisements for the Website Goods listed in part 2 of Schedule 2 to this Statement of Claim referred to substances, or goods containing substances, included in Schedule 4 to the then current Poisons Standard (as that term is defined in s 3 of the TG Act)

 (Poisons Standard) but not in Appendix H of the then current Poisons Standard at all relevant times (Website Schedule 4 Goods).
- 12. The references to substances, or goods containing substances, included in Schedule 4 to the then current Poisons Standard in the advertisements for the Website Schedule 4 Goods were not at any relevant time authorised or required by a government or government authority.
- 13. The conduct of the First Respondent pleaded in paragraphs 3 to 5, having regard to the characteristics of the Website Goods pleaded in paragraphs 6 to 12 above, was in contravention of s 42DLB(1) of the TG Act, in circumstances where:
 - (a) in relation to the advertisements for the Website Goods, s 42DLB(9) of the TG Act applied; and
 - (b) in relation to the advertisements for the Website Schedule 4 Goods, s 42DLB(7) of the TG Act applied.

The After Hours Advertisements

- 14. Between at least 28 October 2019 and 9 January 2020, the First Respondent maintained, or caused to be maintained, a version of the website located at Universal Resource Locator (URL) www.evolutionsupplements.com.au displayed only:
 - (a) between approximately 8pm and 4am on weekdays; and
 - (b) all day on Saturdays and Sundays

(After Hours Website).

15. The After Hours Website displayed advertisements in relation to each of the goods listed in Schedule 4 to this Statement of Claim (**After Hours Website Advertisements**).

Particulars

- (a) The After Hours Website Advertisements were displayed at the URLs listed in Schedule 4, during the periods listed in Schedule 4:
 - i. between approximately 8pm and 4am on weekdays; and
 - ii. all day on Saturdays and Sundays.
- 16. By maintaining the After Hours Website, or causing the After Hours Website to be maintained, the First Respondent advertised, or caused to be advertised, each of the goods listed in Schedule 4 to this Statement of Claim (After Hours Website Goods).
- 17. Each of the After Hours Website Goods is and was, during the period referred to in paragraph 14 above, a therapeutic good within the meaning of s 3(1) of the TG Act.

Particulars

- (a) Each of the After Hours Website Goods is or was, at all relevant times, represented to be, or is or was, at all relevant times, likely to be taken to be, for a therapeutic use, having regard to the representations made concerning the effects and uses of the After Hours Website Goods in the After Hours Website Advertisements.
- (b) Each of the After Hours Website Goods is or was, at all relevant times, represented to be, or is or was, at all relevant times, likely to be taken to be, for use in influencing, inhibiting or modifying a physiological process in persons, having regard to the representations made in column 2 of Schedule 5 to this Statement of Claim in the Website Advertisements in respect of those After Hours Website Goods listed in column 1 of Schedule 5.
- (c) None of the After Hours Website Goods is or was, at any relevant time, the subject of an order in force under section 7 of the TG Act.
- (d) None of the After Hours Website Goods is or was, at any relevant time, a good for which there is a standard within the meaning of s 4(1) of the *Food Standards*Australia New Zealand Act 1991.

- (e) None of the After Hours Website Goods is or was, at any relevant time, a good which, in Australia or New Zealand, has a tradition of use as food for humans in the form in which it is presented.
- (f) None of the After Hours Website Goods is or was, at any relevant time, covered by a determination under s 7AA of the TG Act.
- 18. None of the After Hours Website Goods is or was, at any relevant time, entered in the Register.
- 19. None of the After Hours Website Goods is or was, at any relevant time, the subject of an exemption, approval or authority under the TG Act, nor an exemption, approval or authority under regulations under the TG Act.
- 20. The advertisements for the After Hours Website Goods refer or referred to the rapeutic goods not entered in the Register that are and were at all relevant times prescribed by reg 7(i) of the *Therapeutic Goods Regulations* 1990 (Cth) for the purposes of s 42DLB(9) of the TG Act.
- 21. The references to the rapeutic goods in the advertisements for the After Hours Website Goods were not at any relevant time authorised or required by a government or government authority.
- 22. The advertisements for the After Hours Website Goods listed in part 2 of Schedule 4 to this Statement of Claim referred to substances, or goods containing substances, included in Schedule 4 to the then current Poisons Standard but not in Appendix H of the then current Poisons Standard at all relevant times (After Hours Website Schedule 4 Goods).
- 23. The references to substances, or goods containing substances, included in Schedule 4 to the then current Poisons Standard in the advertisements for the After Hours Website Schedule 4 Goods were not at any relevant time authorised or required by a government or government authority.
- 24. The conduct of the First Respondent pleaded in paragraphs 14 to 16 above, having regard to the characteristics of the After Hours Website Goods pleaded in paragraphs 15 to 23, was in contravention of s 42DLB(1) of the TG Act, in circumstances where:
 - (a) in relation to the advertisements for the After Hours Website Goods, s 42DLB(9) of the TG Act applied; and

(b) in relation to the After Hours Website Schedule 4 Goods, s 42DLB(7) of the TG Act applied.

Application of the TG Act

- 25. The acts of the First Respondent pleaded at paragraphs 1 to 24 above were:
 - (a) things done by a corporation; and/or
 - (b) done in the course of, or in preparation for, trade or commerce between Australia and a place outside Australia, among the States, or between a State and a Territory.

Conduct of the Second Respondent

26. From at least January 2019 to 2 March 2020, the Second Respondent was a person responsible for, and who took part in, the management of the First Respondent.

Particulars

- (a) The Second Respondent has at all relevant times been the sole Director of the First Respondent.
- 27. The Second Respondent was aware that the contraventions of s 42DLB(1) of the TG Act pleaded at paragraphs 13 and 24 above were occurring, or would occur.

Particulars

- (a) On 24 December 2018, the Applicant sent a warning letter by email to the Second Respondent, requiring him to immediately remove from the Website all references to products containing substances included in Schedule 4 to the then current Poisons Standard and to therapeutic goods not entered in the Register and seeking written confirmation of the removal of those references by 2 January 2019.
- (b) On 17 January 2019, in a telephone conversation with Simon Doctor, Assistant Director of the Applicant's Advertising Complaints and Compliance Section, the Second Respondent confirmed that he had received the warning letter and stated that he would not be providing a response or taking any of the actions required by the warning letter.
- (c) On 18 January 2019, the Applicant sent a letter by email to the Second Respondent, indicating an intention to issue him with a direction under s 42DV of the TG Act to cease advertising via the Website goods not entered in the Register and goods

- containing substances included in Schedule 4 to the then current Poisons Standard but not in Appendix H of the then current Poisons Standard.
- (d) On 23 January 2019, a delegate of the Secretary of the Commonwealth Department of Health issued the Second Respondent with a direction under s 42DV of the TG Act by email, requiring him to cease the advertising via the Website of therapeutic goods not entered on the Register (including but not limited to goods containing substances listed in Schedule 10 to the then current Poisons Standard); and to cease the advertising of, and the publication of references to, any substances entered on Schedule 4 to the then current Poisons Standard (**Direction**).
- (e) On 4 October 2019, the Applicant's solicitor sent a letter to the Second Respondent by registered post and email, stating that advertising on the Website continued to contravene the Direction and contravene the TG Act by depicting products containing substances included in Schedule 4 and Schedule 10 to the then current Poisons Standard.
- (f) On 9 October 2019, the Second Respondent emailed the Applicant's solicitor concerning the requirement to remove products from the Website.
- (g) On 11 October 2019, the Applicant's solicitor sent a letter to the Second Respondent by email, referring to the requirement to comply with the Direction and stating that the Website included a large number of pages advertising for sale products containing substances included in Schedule 4 and Schedule 10 to the then current Poisons Standard.
- (h) On 15 October 2019, the Second Respondent emailed the Applicant's solicitor, referring to the removal of products from the Website.
- (i) On 23 October 2019, "jimmy@evolutionsupplements.com.au" sent an email to the First Respondent's email subscribers, stating that "SARMS are now only available online from 8pm to 4am".
- (j) On 25 October 2019, the Applicant's solicitor sent a letter by email to the Second Respondent, stating that the Applicant had not removed from the Website all pages advertising for sale products including the ingredients listed in the letter of 11 October 2019, that it is an offence to advertise therapeutic goods not included in the Register, and that the Website continued to advertise products not included in the Register and/or containing prescription-only substances.

28. The Second Respondent was in a position to influence the conduct of the First Respondent in relation to the contraventions of s 42DLB(1) of the TG Act pleaded at paragraphs 13 and 24 above.

Particulars

- (a) The Second Respondent is the sole Director of the First Respondent.
- (b) The Second Respondent is the addressee for invoices from BigCommerce Pty Ltd for the provision of services relating to the Website.
- (c) The Second Respondent is the contact person for requests made to BigCommerce
 Pty Ltd between July 2017 and July 2019 relating to the operation of and changes to
 the Website.
- (d) The Second Respondent corresponded with the Applicant's solicitor on 9 and 15 October 2019 concerning the requirement to remove products from the Website in terms that indicated he was in a position to control the content of the Website.
- 29. The Second Respondent failed to take all reasonable steps to prevent the contraventions of s 42DLB(1) of the TG Act pleaded at paragraphs 13 and 24 above.
- 30. The Applicant repeats paragraph 25 above, insofar as it relates to the contraventions of s 42DLB(1) of the TG Act pleaded at paragraphs 13 and 24 above.
- 31. The Second Respondent's conduct, as pleaded at paragraphs 26 to 29 above, was done in the course of, or in preparation for, trade or commerce between Australia and a place outside Australia, among the States, or between a State and a Territory.
- 32. The Second Respondent's conduct, as pleaded at paragraphs 26 to 29 above, was in contravention of s 54B(3) of the TG Act.

Failure to comply with Direction

- 33. On 23 January 2019, Nicole McLay, a delegate of the Secretary of the Commonwealth Department of Health issued the Second Respondent with the Direction.
- 34. The Direction required the Second Respondent to cease the advertising via the Website of all therapeutic goods not entered on the Register (including but not limited to goods containing substances listed in Schedule 10 to the then current Poisons Standard); and to cease the advertising of, and the publication of references to, all substances entered on

Schedule 4 to the then current Poisons Standard on the Website, within 7 days of the date of the Direction.

- 35. The Applicant repeats paragraph 26 above.
- 36. The Second Respondent did not, at any time prior to the commencement of these proceedings, cause the First Respondent to cease advertising all therapeutic goods not entered on the Register via the Website.
- 37. At least between 31 January 2019 and 2 March 2020, the Second Respondent did not at any time cause the First Respondent to cease the advertising of, and the publication of references to, all substances entered on Schedule 4 to the then current Poisons Standard on the Website.
- 38. The Second Respondent's omissions, as pleaded in paragraphs 36 and 37 above, contravened the Direction.
- 39. The Second Respondent's omissions, as pleaded in as pleaded in paragraphs 36 and 37 above, contravened s 42DX of the TG Act.

Relief sought

- 40. On the grounds set out above, the Applicant claims the following relief:
 - (a) declarations in the form set out in the Applicant's Originating Application dated4 March 2020;
 - (b) injunctions restraining the First Respondent and the Second Respondent, in the form set out in the Applicant's Originating Application dated 4 March 2020;
 - (c) orders requiring the First Respondent and Second Respondent to pay to the Commonwealth of Australia such pecuniary penalties as the Court determines are appropriate; and
 - (d) costs.
