I forgot to ask in the teleconference: have you submitted to TGA the follow-up to PROactive, mentioned in Takeda's response to the KPNC cohort study?

Takeda has recently completed and submitted (under separate cover) the results from the 4-year interim analysis of study AD-4833/EC-445, which is an ongoing, European, multicentre, observational study of subjects who were previously treated in PROactive (AD-4833/EC-444) with pioglitazone or placebo in addition to their existing antidiabetes and cardiovascular medication.

Since this apparently has a bearing on the issue of bladder cancer, would you be able to submit that data too (or if it has been submitted, would you mind providing a reference submission number)?
