I found the information through the register (cancelled lists). As the listing was such a long time ago all of the records would be in paper. I apologise for not going through how to find the information when the records go way back. I couldn't find any details of changes in the entries so not sure what changes have been made.

The device was first supplied following "Listing" as a Therapeutic Device in 1999 under ARTG entry number 72090. Essure was transitioned to a Medical Device inclusion in September 2007 and was included under ARTG entry number 144330. Due to a change in the manufacturer (Conceptus to Bayer) and sponsor (Device Technologies to Australasian Medical & Scientific) the Essure's ARTG entry changed to 174123.

I have completed the next draft of the Essure paper for ACSMD.

I am having difficulty tracking the history of the device in Australia, including previous Sponsors etc. There appears to have been two previous ARTG entries for the Essure device and 2 previous manufacturers/Sponsors: Sterigenics US LLC and Australasian Medical & Scientific Ltd. Unfortunately I do not have access to the TRIM containers for these previous ARTG entries. Below is the excerpt from the ACSMD paper that I am having difficulty completing.

Do you know where I could access this information?

The first CE Mark Certificate was issued on 9 February 2001 for the Essure model ESS305. The device was approved by the FDA in 2002. The device was first registered on the ARTG in ___ under ARTG number 72090. The Class III Essure System was registered under ARTG number 174123 in July 2010. [1]

The Essure "Female Sterilisation Kit and Plugs" were first registered in Australia under ARTG 72090, manufactured by Sterigenics US LLC. The Essure 305 model was subsequently redeveloped [2] and marketed by Conceptus Inc. In June 2013, Conceptus Inc was acquired by Bayer Healthcare LLC.
