As we discussed on the phone, please try to supply small samples (\sim 500mL) of BlueSil Oil V 1000 and BlueSil RTV 141 parts A & B to the TGA for evaluation.

We understand that these are silicone compounds supplied by Bluestar Silicones. We have the technical data sheets and material safety data sheet for the materials, but we would appreciate more information. Could you please provide more detailed information about the sorts of impurities that are present in the materials. For example: The identity and the amounts of organic contaminants, inorganic contaminants, heavy metals, and additives such as preservatives, etc that are present in the finished materials, as well as the amount and identity of the main ingredients.

If there are any issues related to costs, delivery or timing, please let me know.
