

Order**

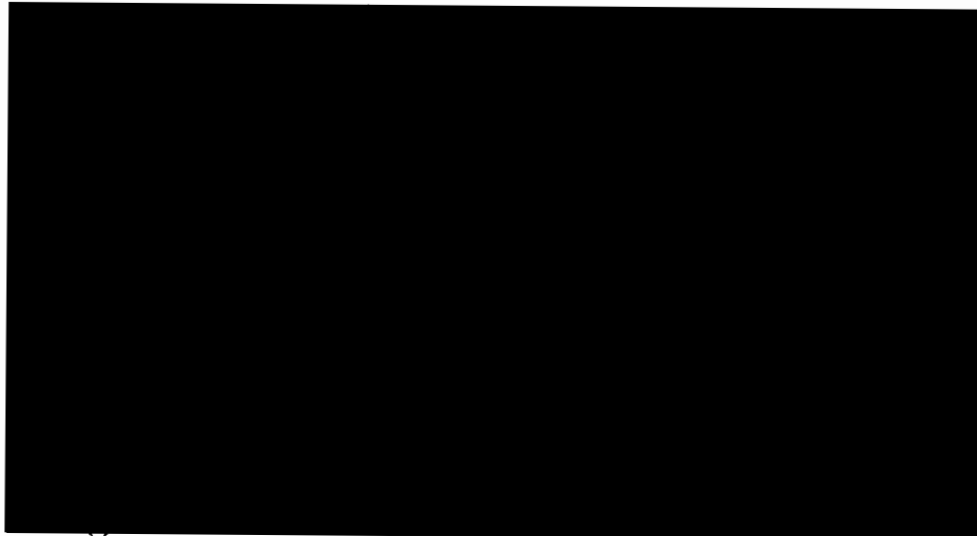
1. This Order may be cited as the Therapeutic Goods (Excluded Goods) Order No. 1 of 1992.

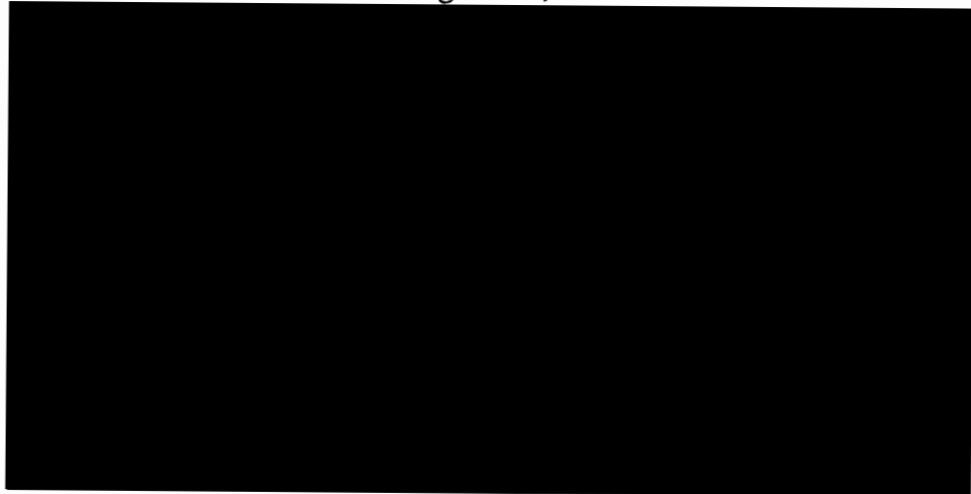
**Goods that are not therapeutic goods**

2. For the purposes of the *Therapeutic Goods Act 1989*, the following goods, being goods intended for use in humans, are declared not to be therapeutic goods:





- (j) equipment, or substances, for use in the purification or fluoridation of drinking water;



2. For the purposes of the *Therapeutic Goods Act 1989*, the goods specified in column 2 in an item in the Schedule, being goods that:

- (a) are intended for use in humans, and
  - (b) are used or labelled in the way specified in column 3;
- are declared not to be therapeutic goods when used or labelled in the way specified.

**Revocation**

3. Therapeutic Goods (Excluded Goods) Order No. 1 of 1991 dated 15 February 1991 is revoked<sup>1</sup>.
