

*Therapeutic Goods Act 1989*

**Therapeutic Goods (Excluded Goods) Order No. 1 of 1992**

TG1/1992

I, DERRICK BEECH, a person to whom the Secretary to the Department of Health, Housing and Community Services has delegated the Secretary's powers under subsection 7 (1) of the *Therapeutic Goods Act 1989*, make the following Order under that subsection.

**Citation**

**1.** This Order may be cited as the Therapeutic Goods (Excluded Goods) Order No. 1 of 1992.

[Note: This Order commences on Gazettal. See *Therapeutic Goods Act 1989*, s. 7 (3).]

**Goods that are not therapeutic goods**

**2.** For the purposes of the *Therapeutic Goods Act 1989*, the following goods, being goods intended for use in humans, are declared not to be therapeutic goods:

(j) equipment, or substances, for use in the purification or fluoridation of drinking water:

3. For the purposes of the *Therapeutic Goods Act 1989*, the goods specified in column 2 in an item in the Schedule, being goods that:

(a) are intended for use in humans, and  
(b) are used or labelled in the way specified in column 3;  
are declared not to be therapeutic goods when used or labelled in the way specified.

**Revocation**

4. Therapeutic Goods (Excluded Goods) Order No. 1 of 1991 dated 15 February 1991 is revoked<sup>1</sup>.
