"Toothpastes and other dental health products containing fluoride are therapeutic goods and are regulated by the TGA."

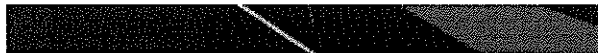
Are there any fluoride containing devices or Comp Meds regulated by us?
