Dear George

Thanks for your email.

The issue is broader than the simple change to the website context. The Australian Dental Industry Association (ADIA) and other stakeholders were expecting that the Therapeutic Goods Administration (TGA) would adhere to its published consultation protocols.

Having met with the Australian National Audit Office (ANAO) yesterday, ADIA has a better understanding of what information they are looking for in terms of understanding the TGA's engagement with industry. This serves as a good example, it gives rise to strong concerns about process if TGA consultation protocols can be amended without notice and stakeholders find themselves unable to rely on the TGA's published statements.

The TGA's act of altering the website text after it has been identified the protocol set out in that text had been breached is not a good look – it certainly raised a few eyebrows at today's meetings in parliament house. It's an act that's certainly going to be assessed in more detail.

As requested, ADIA requests that the recommendation be withdrawn from Ministerial consideration so that the RIS can be prepared and subjected to public review. With that commitment it would be possible to move-on.
