ANTISERUM REAGENT – B/Wisconsin/1/2010 (BX-41A)
FOR SINGLE RADIAL IMMUNODIFFUSION (SRID) ASSAY OF
INFLUENZA VIRUS HAEMAGGLUTININ
TGA Lot: AS426 (DOM: October 2018)

1. Introduction

Influenza antiserum reagent TGA Lot AS426 is prepared for single radial Immunodiffusion (SRID) assay of TGA's B/Phuket/3073/2013-like antigens.

2. Unitage

No unitage is assigned to this material.

3. Contents

Country of origin of biological material: Australia

Animal Species: Domestic sheep (*Ovis aries*)

Donor Sheep Breed: Australian Merino Cross

The purified haemagglutinin (HA) used to immunise sheep was derived from a beta-propiolactone (β PL) inactivated pool of B/Wisconsin/1/2010 (BX-41A) virus. The HA was purified using a protease treatment step prior to further downstream purification.

All sheep used in the production of antisera were inspected by a veterinary surgeon prior to terminal bleed confirming their disease free status. The antiserum contains 0.1% sodium azide as preservative.

4. Caution

THIS PREPARATION IS NOT FOR ADMINISTRATION TO HUMANS.

The preparation does not contain material of human origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. It should be used and discarded according to your own laboratory's safety procedures. Such safety procedures probably will include the wearing of protective gloves and avoiding the generation of aerosols. Care should be exercised in opening ampoules or vials, to avoid cuts.

5. Use of material

For SRID testing of influenza virus antigens; this antiserum is suitable for the testing of B/Wisconsin/1/2010 (BX-41A)-like and B/Phuket/3073/2013-like antigens. For the TGA antigen B/Phuket/3073/2013 Lot 2018/117B containing approximately 20-30 µg HA per mL, add 3µL of the undiluted antiserum to 1 mL of agarose. It may be necessary to change the antiserum concentration according to local laboratory conditions.

Antiserum reagent AS426 should be used according to the method described by Wood, JM, Schild, GC, Newman, RW, and Seagroatt, VA, Journal of Biological Standardisation, 1977, 5, 237-247.

6. Stability
