Following is a breakdown of public submission responses forwarded to the TGA via our platform, as requested.

A total of 5,399 submissions were received between 17-22 May, which is the period the portal was open. Of these:

- 54.2% supported the 'hybrid' proposal by Complementary Medicines Australia (CMA)
- 41.5% supported the proposal by a private individual
- 4.3% supported the TGA proposal





Q2. Select the category that best represents you.




Q5. For what reasons would you or your loved ones like to try CBD?



Q6. Which of the following best supports your views?


